Local Area 911 Agencies Launch Text to 911 Service - "911: Call if You Can, Text if You Can't"

Emergency Communications of Southern Oregon (ECSO) and Josephine County 9-1-1 now accept Text-to-911 messages in response to emergencies. Text-to-911 is intended to benefit people that may not be able to speak due to an emergency such as a home invasion or abusive partner; as well as individuals that are deaf, hard of hearing, or have speech disabilities. A few things you should know about how Text-to-911 works currently: Texting to 911 is intended to benefit people that may not be able to speak in an emergency. The key thing to remember is "Call if you Can, Text if you Can't". When texting to 911 for an emergency, the first message should be the location of the emergency (including city) and the type of emergency help needed (police, fire, or medical). Keep text messages brief and concise; using full words. Stay with your phone. Be prepared to answer questions and follow instructions from the 911 call taker. Photos, videos and emoji cannot be sent to 911 at this time. Trying to send these will corrupt the call text. You cannot include 911 in a group text or while roaming.

Text-to-911 service is not yet available statewide in Oregon or California. If you send a text to 911 from a wireless carrier or a city/county without Text-to-911 service, you should receive a message saying that there is no text service to 911 available at this time. WATER OUALITY REPORT NOW AVAILABLE ON LINE

The Medford Water Commission and the City of Eagle Point have provided water quality information to its customers on a regular basis for decades. About fifteen years ago annual water quality reporting became mandatory and more formalized under changes in federal regulations, after which we began distributing these reports each year through mass mailing. While we support the rights of our customers to receive this information, the printing and mailing of these reports has been a substantial expense, and for those customers who didn't desire to read the report, a waste of paper as well. Meanwhile, over the last several years, use and access to the internet has become widespread. Like last year, we will not be distributing the annual water quality report through bulk mailing. Rather, within the next few weeks, customers can now easily access this report online at www.medfordwater.org/WaterQualityReport.pdf or www.cityofeaglepoint.org and click the water quality report link. Of course, we recognize that some customers do not have internet access and/or would prefer a paper copy. We are therefore printing some hard copies, which will soon be available upon request by calling 541-826-4212. Call 541-826-4212 ext. 136 regarding any questions in the water quality report. As always, this report contains important information on the results of water quality testing during the prior year, as well as explanations of what these results mean. Information on the sources of our drinking water is also included, as well as water conservation tips to help customers save water and money. The online report also includes links to additional information, while also reducing the amount of paper received in mailboxes.

Directly following this hearing, a public meeting of the Budget Committee of the City of Eagle Point, Jackson County, State of Oregon, will be held to discuss the budget for the fiscal year July 1, 2017 to June 30, 2018.

Notice of Public Hearing: There will be a public hearing during the regular City Council meeting on June 13, 2017 at 7:00 p.m. in the Eagle Point City Council Chambers, 17 Buchanan Ave. South, Eagle Point, Oregon, in the matter of authorizing an increase of the Water Base Rate and Water Consumption

Notice of Public Hearing: The City Council will conduct a public hearing on June 13, 2017 at 7:00 p.m. in the City Council Chambers at City Hall, 17 South Buchanan Avenue, Eagle Point, Oregon to consider an application to subdivide and develop the property at Tax Assessors Map 351W34BD, Lot 200 in the R-1 Single-Family Residential zoning district.

Nuisance Weed/Excessive Vegetation Abatement - All property owners within the City limits with property less than one acre are required to cut vegetation to less than 10 inches prior to June 1st. For properties greater than one acre in the City limits, a 15-foot fire break (30 feet from any structure, including a fence) is required. The vegetation must be maintained in this manner until October 1st or the end of fire season (whichever is later).
